## THIS IS AN EXAMPLE OF OVERCROWING YOUR TEXT

- YOU DON'T NEED TO TYPE IN EVERY WORD YOU WANT TO SAY.
- THIS CAN BE DISTRACTING TO YOUR AUDIENCE AND IS NOT PROPER USE OF PRESENTATION SOFTWARE.
  - ALSO, INDIVIDUALS TAKING NOTES ON YOUR PRESENTATION WILL STRUGGLE TO SUMMARIZE THE IMPORTANT INFORMATION FOR THE BRIEF PERIOD.
  - You should summarize it into 3 6 bullets that are no more than 6 words long.
- Don't get carried away and add too much text Break it up!
- SLIDES LIKE THIS TAKE AWAY FROM THE MESSAGE AND CAN GET LOST IN TRANSLATION.
- YOU ALSO MAY WASTE TOO MUCH TIME ON A SINGLE SLIDE, LOSING YOUR AUDIENCE.
- SOME OF THE AUDIENCE MAY ONLY FOCUS ON THE SLIDE AND NOT LISTEN TO WHAT YOU'RE SAYING.

#### EXPERT TESTIMONY


- Blasdell v. State, (CCA 2015), excluded expert testimony on weapon-focus effect on eyewitness identification.
- Proponent must prove by clear and convincing evidence it is reliable
- Reliability requires proof that it is generally accepted in the professional community.
- No evidence of error rate or whether literature in the scientific community supports or rejects the theory.
- Expert had not published any peer reviewed articles or conducted any of his own studies.

#### DISJOINTED FLOW

- REMEMBER YOUR POWERPOINT IS ONLY
  THERE TO HELP YOU GET YOUR
  MESSAGE ACROSS
- SET UP YOUR SLIDES TO FLOW WITH YOUR MESSAGE
- HAVE A BEGINNING, MIDDLE & END JUST LIKE A STORY



#### POOR DESIGN

#### **Bad font choices:**

This font is too small

### This font is too large

- This font is too fancy
- · This font color is hard to read
  - this font doesn't line up
- very well with the other lines
  - · Making it very hard to read

#### Annoying Custom Animation

- · Select one type of animation
- And use it for each block of text
- DO NOT SELECT ANIMATION THAT MAKES YOUR READER NOT WANT TO FOLLOW ALONG
- Do not pick animation that wastes time for no reason
- •Annimation that is too "busy" is also annoying!

#### START WITH THE END IN MIND

- THINK ABOUT:
  - THE PURPOSE OF YOUR PRESENTATION
  - WHY YOU WERE ASKED TO SPEAK
  - What the audience expects
  - WHAT THE MOST IMPORTANT ASPECTS ARE





Who is your audience? (Lawyers v Jurors)



Are you trying to Inspire? Convey info? Convince?





Knowing these things will help guide you when creating a PowerPoint presentation

#### KEEP IT SIMPLE

- DON'T LET YOUR MESSAGE
  GET DERAILED BY SLIDES THAT
  ARE:
  - UNNECESSARILY
     COMPLICATED
  - Busy
  - FULL OF MEANINGLESS
     PICTURES/GRAPHICS
- LESS CLUTTER = MORE POWER

#### LIMIT BULLET POINTS & TEXT

Some slides may not have any words at all



#### LIMIT BULLET POINTS & TEXT

- GOOD SLIDES SHOULD BE OF LITTLE USE WITHOUT YOU
- Your written material should highlight & expand your presentation content
- Your PowerPoint should be a tool in Getting Your Message across



#### LIMIT ANIMATIONS

- STICK TO THE MOST SUBTLE AND PROFESSIONAL ANIMATIONS
- THINK OF WHAT YOU MIGHT SEE
   ON THE EVENING TV NEWS
   BROADCAST

## USE HIGH-QUALITY GRAPHICS

- NEVER STRETCH A SMALL, LOW-RESOLUTION PHOTO TO MAKE IT FIT YOUR LAYOUT
- AVOID CHEESY CLIP-ART
- IF YOU HAVE A POWERFUL PICTURE, DON'T USE ANY TEXT





#### BE CREATIVE

- Just like a good story your PowerPoint needs to be creative!
- YOUR AUDIENCE EXPECTS YOU SOMETHING NEW & EXCITING
- YOU CAN LOOK TO OTHER PRESENTATIONS FOR GUIDANCE, BUT MAKE IT YOUR OWN!!


#### IF APPLICABLE, USE CHARTS!

Charts and graphs can be more powerful than words

Be sure they help highlight the most important aspects of your presenation

#### How many people are locked up in the United States?

The U.S. locks up more people per capita than any other nation, at the staggering rate of 698 per 100,000 residents. But to end mass incarceration, we must first consider *where* and *why* 2.3 million people are confined nationwide.



#### CHOSE YOUR COLOR WELL

- COLOR CAN CONVEY EMOTION
- COOL COLORS (BLUE/GREEN) WORK BEST FOR BACKGROUNDS AS THEY APPEAR TO RECEDE AWAY FROM AUDIENCE
- WARM COLORS (ORANGE/RED) GENERALLY WORK BEST FOR
  OBJECTS IN THE FOREGROUND (SUCH AS TEXT) BECAUSE THEY APPEAR
  TO BE COMING AT AUDIENCE



## CHOSE YOUR FONT WELL

- FONTS COMMUNICATE SUBTLE MESSAGES IN AND OF THEMSELVES
- Use the same font throughout your presentation
- FOR ON SCREEN PRESENTATIONS, SERIF FONTS
   TEND TO GET LOST DUE TO THE RELATIVELY LOW
   RESOLUTION OF PROJECTORS



## USE VIDEO AND AUDIO WHERE APPROPRIATE





Using video clips to show concrete examples promotes active cognitive processing

Videos/audio can increase interest

### USING VIDEO FROM YOUTUBE/ONLINE SOURCE

- In PowerPoint, click the slide that you want to ADD A VIDEO TO.
- ON THE INSERT TAB, CLICK VIDEO > ONLINE VIDEO.
- In the From a Video Embed Code Box, paste the embed code, and then click the arrow.
- A **VIDEO** RECTANGLE IS PLACED ON YOUR SLIDE, WHICH YOU CAN MOVE AND RESIZE AS YOU LIKE.

## IF NOT ONLINE, DOWNLOA D AND ATTACH A VIDEO

- CLIPCONVERTER.CC IS A FREE WAY TO DOWNLOAD VIDEOS FROM YOUTUBE OR ONLINE SOURCES
- ALLOWS YOU TO DO SO WITHOUT INSTALLING ANY NEW SOFTWARE




#### Welcome to Clip Converter - YouTube to MP4 & MP3 Converter!



**Clip Converter** is a free online media conversion application, which allows you to reocord, convert and download nearly any audio or video URL to common formats. Currently supported services: YouTube (HD, 720p, 1080p, 4K), Vimeo, Facebook Video and many more. Just try it out! This free and fast converter allows you to watch your favorite YouTube videos offline on your PC, TV or nearly any other device.

#### How to convert and download a YouTube video:

- 1. Paste your YouTube URL at 'Video URL' and press Continue.
- 2. Select the format (MP3, MP4, M4A) and the quality (720p, 1080p, 2k, 4k) for the conversion. The default options are a good start for most videos.
- 3. Press the 'Start' button at the bottom to start the conversion.
- 4. This may take several minutes. After the conversion is finished you can download the converted file.



# HOW TO CONVERT AND DOWNLOAD A YOUTUBE VIDEO:

- 1. PASTE YOUR YOUTUBE URL AT 'VIDEO URL' AND PRESS CONTINUE.
- 2. SELECT THE FORMAT (MP3, MP4, M4A) AND THE QUALITY (720P, 1080P, 2K, 4K)
- 3. Press the 'Start' button at the bottom to start the conversion.
- 4. AFTER THE CONVERSION IS FINISHED YOU CAN DOWNLOAD THE CONVERTED FILE.
